From the Vice-Dean's Corner:

Well, it's that time of year again, as we prepare for Tri-Council grant application deadlines, beginning this summer. (As if it weren't always that time of year!) For CIHR Project grants, we expect an August registration date, with full applications due in September. NSERC Discovery grants have a registration deadline of August 1st, with applications due on November 1st. The deadline for SSHRC Insight grants is October 15th. The CIHR has prepared a helpful guidebook on grant application writing, entitled Advice on Applying for a Grant, Writing Papers, Setting up a Research Team and Managing Your Time, which has echoes in similar documents about submitting to NSERC and SSHRC. <http://www.cihr-irsc.gc.ca/e/27491.html#1.2> Most notably, the guidebook stresses the importance of starting preparations early. Based on these recommendations, we suggest the following timeline:

- 12 weeks before deadline: Write the Overall Goal and each Specific Aim. Start gathering accompanying documents, such as CVs and supporting letters. (Aim to have them 4 weeks before the deadline.)
- 6 weeks before deadline: Start writing, a little every day.
- 3-4 weeks before deadline: Have a full draft proposal ready for review by internal mentors, collaborators, research office.

Your Faculty Research Office is working closely with the Office of the Vice-President Research to offer a variety of useful and efficient services for grant writing that include competition-specific workshops and internal review mentors. In the meantime, we urge researchers, especially new investigators and those who are transitioning into new areas of investigation, to contact us at the earliest opportunity about getting an internal review. The sooner we know your needs, the more likely we are to be able to provide quality input to your application.
